1	TRADE NAME	Deadline Wax Blocks
2	ACTIVE INGREDIENT	Bromadiolone 0.005%
3	PURPOSE	Outdoor Rat Control
4	APPEARANCE	Blue ready to use grain bait based block
5	HAZARD	Hazardous by ingestion avoid contact with mouth and skin
6	HANDLING / USAGE	Avoid all contact by mouth. Wash hands and exposed skin before eating, drinking and smoking and after work. Read the label before use.
7	MIXING	This is a ready to use product. Do not mix.
8	APPLICATION	To be secured in a suitable bait station
9	RESTRICTIONS	Use only as a rodenticide
10	PPE	Gloves, Overalls
11	RPE	N/A
12	ROUTES OF ABSORPTION	Ingestion
13	WEL (workplace exposure limit)	Not on EH40 List.
14	FIRST AID MEASURES	Eyes - Rinse with water for at least 15 minutes holding eyelids apart. Rinse entire surface and do not allow run off to contaminate unaffected eye. Seek medical attention. Skin - Remove and wash contaminated clothing immediately. Wash area with soap and water. Ingestion - Do NOT induce vomiting. If unconscious place in the recovery position. If conscious give patient 1 pint of water to drink and seek medical advice. Inhalation - Unlikely. Antidote: VITAMIN K1
15	FIRE	Use foam, carbon dioxide or dry powder extinguishers. Wear SCBA and suitable protective clothing if fighting fire. Combustion or thermal decomposition may evolve toxic or irritant vapours.
16	STORAGE	Store in original container. If decanted, container must be labelled. Product must only be stored in a PESTPROOF LTD vehicle or PESTPROOF LTD stores.
17	TRANSPORT	Product must be transported in the pesticide storage area of company van or in a sealed container. Container must have lid fitted and be secured to avoid spillage. Container must be carried in specialist's holdall and not left unattended at any time.
18	SPILLAGE	Wear suitable personal protective equipment. Collect up spilt material and transfer to suitable container for re-use or subsequent disposal. DO NOT contaminate watercourses or ground.
19	WASTE DISPOSAL	Remove and dispose of in accordance with company procedures for the disposal of waste rodenticide. Dispose of as hazardous waste in accordance with local regulations.
